Key Facts

Passed in March 2021, HB 48 ensures that pharmacists can bill and be compensated by medical insurances for services they provide. Here are 4 important points to take away:



What is HB 48?

An act relating to the reimbursement of pharmacy services in Kentucky effective July 2021. HB 48 establishes when a commercial insurer or third-party administrator for a commercial insurer will provide reimbursement to a pharmacist for a provided service or procedure by amending KRS Chapter 304 Insurance Code



Which payors must reimburse pharmacists for services provided under HB 48?

HB 48 is **limited to commercial payors only**. It does not include patients with Medicaid or Medicare



How much will a pharmacist be paid for services that are billed?

Per KY 21 HB 48, payment for services shall not be at a rate less than that provided to other non-physician practitioners



Why can't I just bill claims now?

You can in some instances. Some payors have adapted more quickly than others to accepting medical billing claims by pharmacists. Others have to prepare to receive claims internally by changing their systems to acknowledge pharmacists as providers and covered services amongst others



What type of services will be covered?

Payors must compensate pharmacists if the service or procedure is within the scope of practice AND would otherwise be covered if a physician, APRN, or PA performed it. Some examples are as follows:
